

QUORUM

As the meeting required 17 members to be present to form a quorum and only 15 members were present, the meeting was adjourned for half-an-hour after which those present were deemed to form the quorum. This was provided for under Article 8b of the Association's Constitution.

WELCOME AND APOLOGIES

The AGM began at 5.30 pm with a word of welcome from Dr P K Wong, the President of the Association. Dr Wong noted that the Association had had a reasonably good year and thanked all members and well-wishers of the Association for the support they had given to the Association in the first year of its formation.

Constitution did not allow for this and also this was not the practice in many societies and associations. Members joining after the financial year had begun would still be required to pay the full membership fee. However, he said that the Association would monitor this and if a large number of people were deterred from joining the Association as a result of not enjoying pro-rated subscription, then the Association could consider amending the Constitution to provide for this situation.

Prof Chao asked whether the Association would be launching a membership drive and that incentives be given to those who help to recruit new members. Dr Wong said that the new Exco would look into this suggestion.

Dr Wong then briefed members present on the proposed formation of the Asia Pacific Association for Medical Informatics. The proposal was actually mooted by the Royal Australian College of General Practitioners (RACGP) which is keen to link up associations for medical informatics in the Asia-Pacific region. In addition to Singapore, the RACGP had also got in touch with medical informatics associations in Hong Kong and the Philippines. China and Japan had also indicated that they would be keen to join the regional group. This proposal had also been favourably received by the IMIA board when they discussed it during their board meeting in Singapore last May. The RACGP proposed to form the Asia-Pacific Association during the First Pan-Pacific Conference on Business and Medical Computing to be held in the Pan-Pacific Hotel in Singapore in October. Dr Wong said that AIM would be favourably inclined towards joining the Asia-Pacific Association and having a permanent secretariat based in Singapore. On the latter note, we would have the support of China. Singapore would support Australia for the presidency of the regional association since the Australians were the ones who started the ball rolling.

Dr Wong asked whether the members present had any strong objection to the Association pursuing this matter of joining an Asia-Pacific Association for Medical Informatics. The members present unanimously supported the Association's stand.

As there were no other matters, Dr Wong thanked all members present for their support and closed the meeting at 6.45 pm.
