The Organizational Issues of Medical Informatics

INTRODUCTION

As biomedical knowledge has increased exponentially, professionals have developed strategies to cope with the vast volume of medical knowledge. As technology became more sophisticated and widespread, the management strategies for coping with the body of biomedical knowledge sometimes became more diffuse or much less clearly defined.

As rapid technological change is instituted into organizations, many accompanying issues, e.g. what is the vision of the organization for managing the information? What could or should be done first, second, third? Who is in charge of managing and making the decisions for this very complicated and complex area? How does the organization respond to the unclarity and uncertainty of the rapid changes?

Organizational stress is caused by rapid change. The implementation of technology more rapidly than the members of the organization are capable of assimilating the technological implications also causes stress. The end users of the technology may not know effective ways to express their needs, and thus do not participate, or they were not asked to participate in the decisions in the first place. When a broad based distribution of technology occurs, sometimes the end users and the developers/implementers of the technology find that they have not spoken the same language.

PROPOSAL

This proposal is to invite 25-40 informatics and organizational professionals to a working group conference which will focus on the organizational impact of informatics.

The objectives of the working group conference include:

- (1) To identify and define effective leadership characteristics which support the successful implementation of informatics principles in organizations.
- (2) To identify methodologies for determining strategic direction of informatics within organizations.
- (3) To identify effective organizational structures for different types of organizations with regard to informatics.
- (4) To identify, define, and promote effective strategies for introducing change in complex medical organizations.
- (5) To promote training programs to increase the awareness of informatics professionals with regard to the organizational issues.
- (6) To maintain liaison with appropriate national organizations with an interest in medical informatics generally and organizational implications specifically.
