1. Marketing Activities

The "IMIA Flyer" has been redesigned to project a stronger image to the public at large. It has been distributed at a variety of meetings and is available for download on the new IMIA website (see the Executive Director's report for details).

We have introduced a new item on the IMIA web page "Books and Journals". This facilitates publishing companies listing new and existing books and journals on the website with direct links to enable visitors to order books or subscribe to journals. Healthcare Informatics, one of our existing Corporate Members, has agreed to act as our first trial in this area. It is our hope that this facility will provide an inducement to publishers to join as IMIA corporate members.
